Detailed Advertisement for Appointment of Vice-Chancellor, Vardhaman Mahaveer Open University (VMOU), Kota

Hon'ble Governor and Chancellor, VMOU, Kota has been pleased to form a Search Committee by means of Order vide No. F.25(2)RB/2022/3394 dated 26.06.2025, as per provisions of section 8.3 of the Vardhaman Mahaveer Open University, Kota Act, 1987 (as amended 2019) for recommending a panel of names for the appointment of a regular Vice Chancellor of the University. The Committee in its first meeting has directed to float the Advertisement, as under:

As provided U/S 8.3 of the Vardhaman Mahaveer Open University, Kota Act, 1987 (as amended 2019), the Vice Chancellor of the Vardhaman Mahaveer Open University, Kota (a State Funded University of Rajasthan) is a whole time paid officer of the University and shall be appointed by the Chancellor in consultation with the State Government from amongst the persons included in the panel recommended by the Search Committee constituted by the Chancellor for the purpose. As per provisions of section 8.7 of the Vardhaman Mahaveer Open University, Kota Act, 1987 (as amended 2019), the term of the office of the Vice Chancellor shall be three years from the date on which he or she enters upon his or her office or until he or she attains the age of 70 years, whichever is earlier, along with other terms of service as provided under section 8 of the Vardhaman Mahaveer Open University, Kota Act, 1987 and its Amendment, 2019.

Sec. 8(2) of the Vardhaman Mahaveer Open University, Kota Act, 1987 and its Amendment, 2019 (available on University's website www.vmou.ac.in) prescribes-

"No person shall be eligible to be appointed as Vice-Chancellor unless he is, a distinguished academician having a minimum of ten years experience as Professor in a University or college or ten years experience in an equivalent position in a reputed research and/or academic administrative organization and, of highest level of competence, integrity, morals and institutional commitment.

Accordingly, the Search Committee invites applications, in the prescribed Standard Format of CV, preferably by email in PDF format, from persons who have attained academic excellence and demonstrated leadership qualities in education and have the requisite minimum qualifications as per section 8(2) of the Vardhaman Mahaveer Open University, Kota Act, 1987 and its Amendment, 2019 in the prescribed 'Standard Format of CV' for appointment to the post of Vice-Chancellor, Vardhaman Mahaveer Open University, Kota.
