**General Instruction to be followed by the Ph.D. Scholars:**

1. The candidate registered for Ph.D. degree shall not be allowed to take up any other University Examination. However, in exceptional cases, the Vice-Chancellor may grant such permission in the interest of research, on the recommendation of the supervisor.
2. During the registration for Ph.D. programme Candidate will have to maintain discipline and obey the instructions issued by the concerned officers of the University from time to time.
3. Ph. D. student shall publish one research paper in a refereed journal before submission of the thesis and produce evidence for the same in the form of acceptance letter or reprint.
4. The research candidate will have to give two seminars presentations with a gap of six months for the second seminar, Prior to submission of the thesis, the student shall make a Pre-Ph.D. presentation in the Department/School that may be open to all faculty members and research students, for getting feedback and comments, which may be suitably incorporated into the draft thesis under the advice of the supervisor.
5. The minimum period required for submitting the doctoral thesis shall be two years and maximum five year from the date of registration in the research programme.
6. Extension of one year may be granted provided the student applies before the completion of five years. The request for extension shall be considered only on the recommendation of the supervisor(s).
7. No re-registration is allowed.
8. A candidate will deposit one year tuition fee in advance on receipt of registration letter and every year annual tuition fee shall be deposited in advance.
  - a) Failure to pay the prescribed fee;
  - b) Unsatisfactory performance of research-work;
  - c) defiance/violation of rules/directives/instructions/ordinances at any level;
  - d) Any act of indiscipline;
  - E) Failure to submit the thesis within the prescribed time limit etc.
9. The Candidate will have to abide by all the ordinances and directives with regard to Ph.D. programme and provisions of the University Act and Statutes.
